AND:

(hereinafter called "Falk")

OF THE SECOND PART.

WHEREAS Falk has created a limited edition serigraph described as "NORTH SHORE ROSES" and has donated it to the School Board's "Artists for Kids" program (the "Program");

AND WHEREAS the School Board now intends to market the edition of 150 prints of "NORTH SHORE ROSES" to raise funds for the Program;

NOW THIS AGREEMENT WITNESSES that, in consideration of One Dollar (\$1.00) now paid by the School Board to Falk and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. Falk will permit the School Board to, and the School Board will, at its own expense, produce 150 prints, plus 15 artist's proofs and 3 printer's proofs of "North Shore Roses" as a limited edition, and Falk will sign and number each print.
- 2. All proofs of the serigraph, except 3 printer's proofs and 15 artist's proofs, will be destroyed immediately upon completion of the limited edition. Falk will receive, at no cost to her, the 3 printer's proofs and 15 artist's proofs, to use as designated by her at her sole discretion.

- 3. The School Board will bear the cost of printing and selling the edition of 150 prints and will be entitled to all profits derived therefrom.
- 4. The School Board will have the right to publish promotional literature and advertisements of the prints.
- 5. Falk shall own the copyright of "NORTH SHORE ROSES" and all prints and reproductions.
- 6. The School Board hereby indemnifies Falk against all costs, expenses, claims, demands, and other liabilities of whatsoever nature, except those which are voluntarily incurred by Falk, arising out of or in connection with the said prints or the advertising and marketing thereof, or the School Board's exercise of the rights granted under this Agreement.
- 7. The School Board's rights and obligations under this Agreement shall not be assigned without the prior written consent of Falk. Subject thereto, the Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.
